Exercise of Warrants and Total Voting Rights

London, England - Newfoundland and Labrador, Canada – Rambler Metals and Mining plc (AIM: RMM) (“Rambler” or the “Company”), a copper and gold producer, explorer, and developer, announces that it has received notification to exercise 12,750,000 warrants at an exercise price of 0.2p each. The consideration received by the Company will be £25,500.

The 12,750,000 new ordinary shares arising from the exercise of these warrants (“Warrant Shares”) will shortly be issued, and application has been made for them to be admitted to trading on AIM (“Admission”). It is expected that Admission will become effective and dealings will commence at 8:00a.m. on or around 30 April 2021.

Following Admission, the Company will have 10,731,098,677 ordinary shares of 0.01p each in issue, none of which are held in treasury. Therefore, the total number of voting rights in the Company is 10,731,098,677.

The above figure of 10,731,098,677 may be used by shareholders in the Company as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change in their interest in, the share capital of the Company under the FCA's Disclosure and Transparency Rules.

Rambler is a mining and development company that in November 2012 brought its first mine into commercial production. Rambler has a 100 per cent ownership in the Ming Copper-Gold Mine, a fully operational base and precious metals processing facility and year-round bulk storage and shipping facility; all located on the Baie Verte peninsula, Newfoundland and Labrador, Canada.

Rambler’s focus is to regain its production profile at 1,350 metric tonnes per day at 2% Cu in the course of 2021 and evaluate expansion opportunities from that base.

Along with the Ming Mine, Rambler also owns 100 per cent of the former producing Little Deer/Whales Back copper mines.

Rambler is listed in London under AIM:RMM.
